- The AVPA certification is open to any food product, which can be stored at room temperature for at least three months, which is suitable for tasting as it is, without complex implementation, made from traceable components stated by the producer.
- The AVPA certification is carried out by an AVPA jury that aims to recognize the originality of taste, recipe or appearance and to analyse the finesse and length in the mouth that make it a memorable product. The jury's decision is final.
- The producer recognizes the right of the association to mention the results of the tasting by any appropriate means in the media and media it has chosen (website, catalogue, sheets, etc.).
- When the results are announced and if the product is certified as an AVPA Gourmet Product:
  - The signed diplomas will be sent by email or the originals given to the producer ( if he will show up at the association's headquarters) or sent by courier at the expenses of the producer.
  - the producer will commit to put on its packaging a reproduction of the medal according to a license proposed by AVPA, the amount of which will be calculated according to its production with a minimum of 100 euros.
  - The producer will send to AVPA as soon as possible:
    - (a) all the information and photos needed to produce a presentation sheet for the producer and the product.
    - b) for each AVPA Gourmet Product, as samples with no commercial values, at least two cartons of sales units
- The producer states that he has been made aware of the participation Terms and Conditions, which he declares to accept without reservation or restriction and declares that he will not take any action against AVPA, which disclaims any liability for any error or omission.
